

# OFF LIMITS AREAS

## **Justification:**

- Crime and misconduct
- Gambling (when in violation of state and local laws)
- Liquor violations
- Unsanitary and adverse conditions
- Prostitution
- Discriminatory practices
- Unethical or illegal business practices

## **Procedures:**

- Refer complaint to appropriate agency (ACS Consumer Affairs, SJA, Safety, EEO, IG, etc. )
- Appropriate agency conducts initial interview and preliminary investigation.
- SJA notifies the establishment of intent to place off limits.
- Investigation, surveillance, and appropriate coordination is completed.
- Results presented to the Armed Forces Disciplinary Control Board (AFDCB).
- AFDCB recommends off limits areas to the CG for his approval.
- SJA notifies the establishment that it is placed off limits.

## **Enforcement:**

- IAW AR 190-24, areas subject to monitoring by state, local, and military LE
- SMs subject to action under Art 92 UCMJ
- SMs subject to civilian LE detention, questioning, then release to military control




